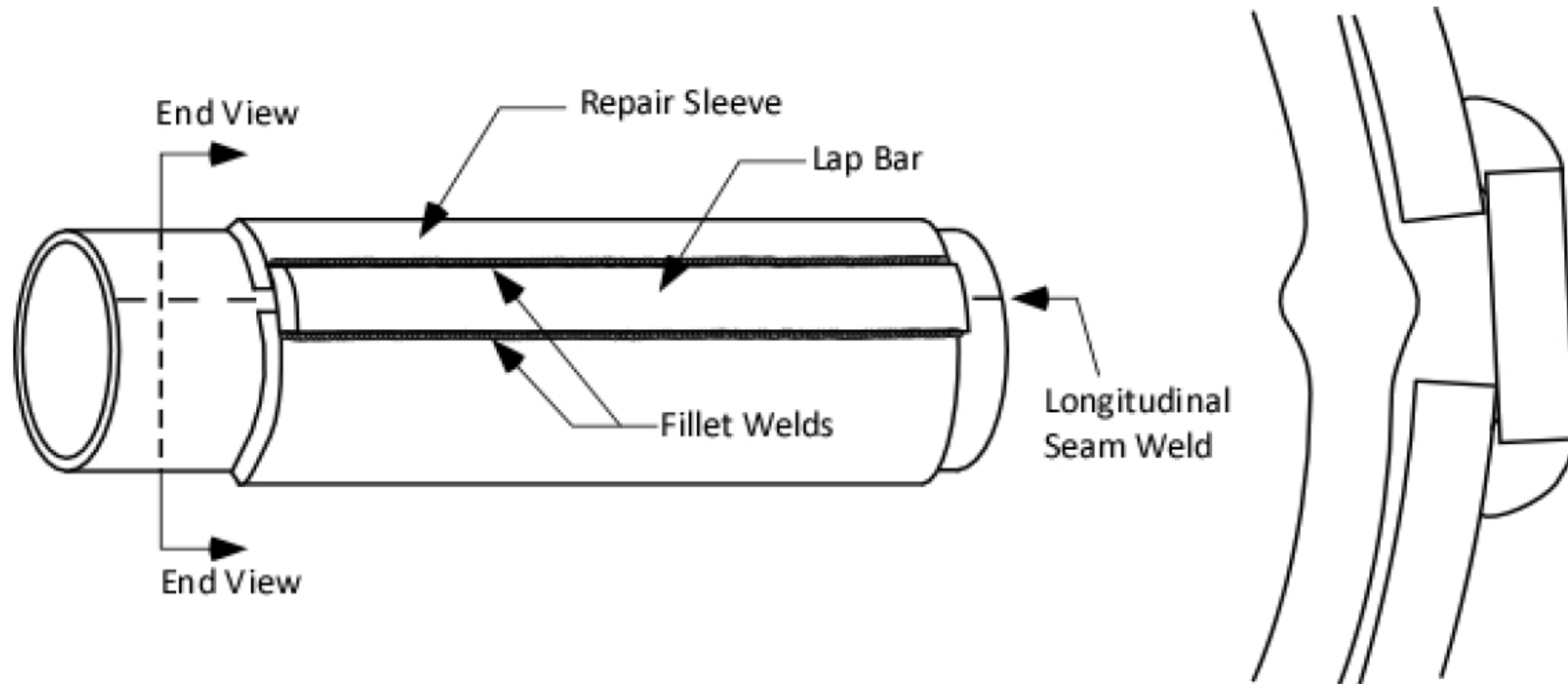


Figure 11. Seam weld reinforcement positioned in gap created by side strip.

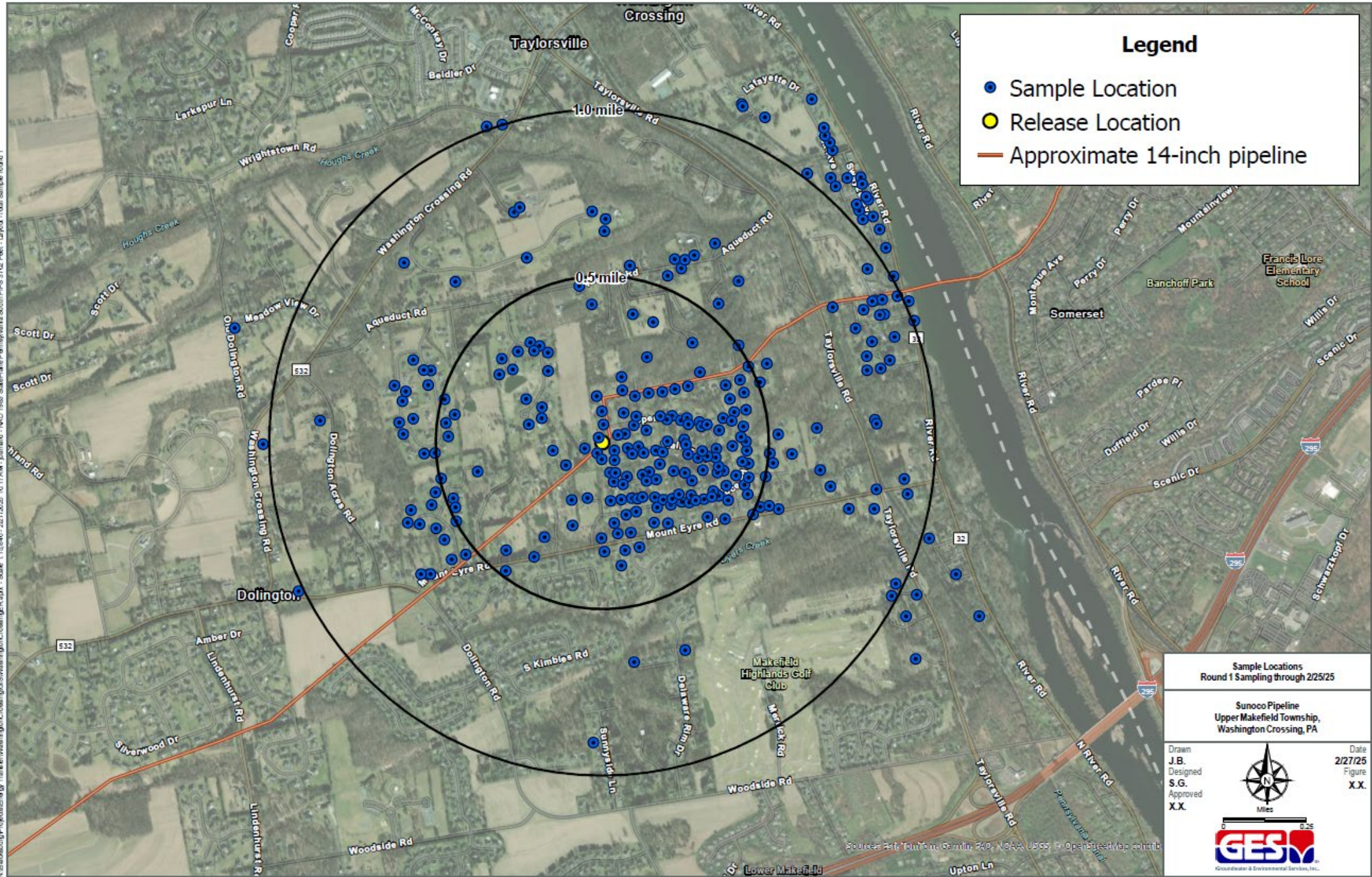

Legend

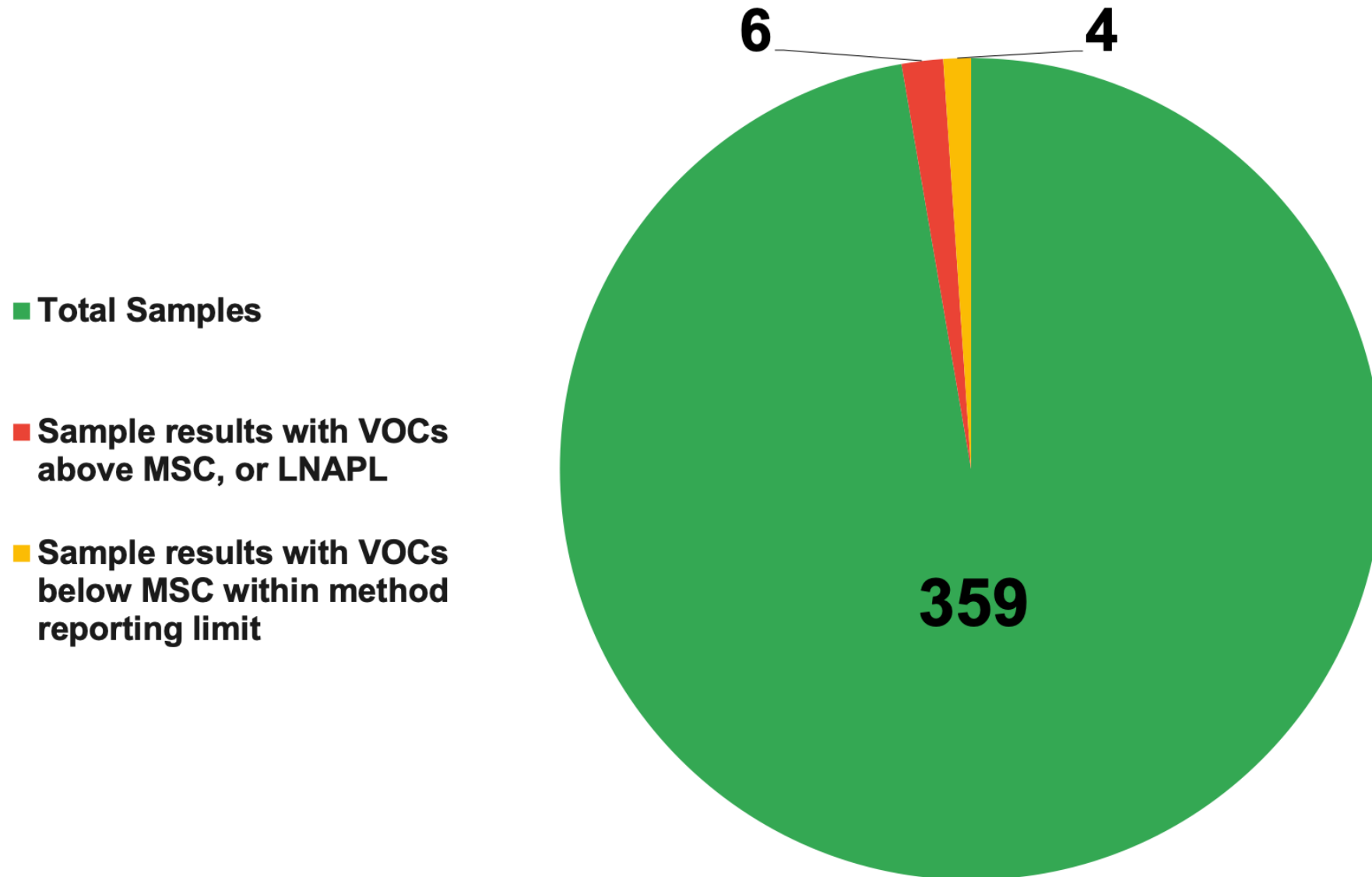

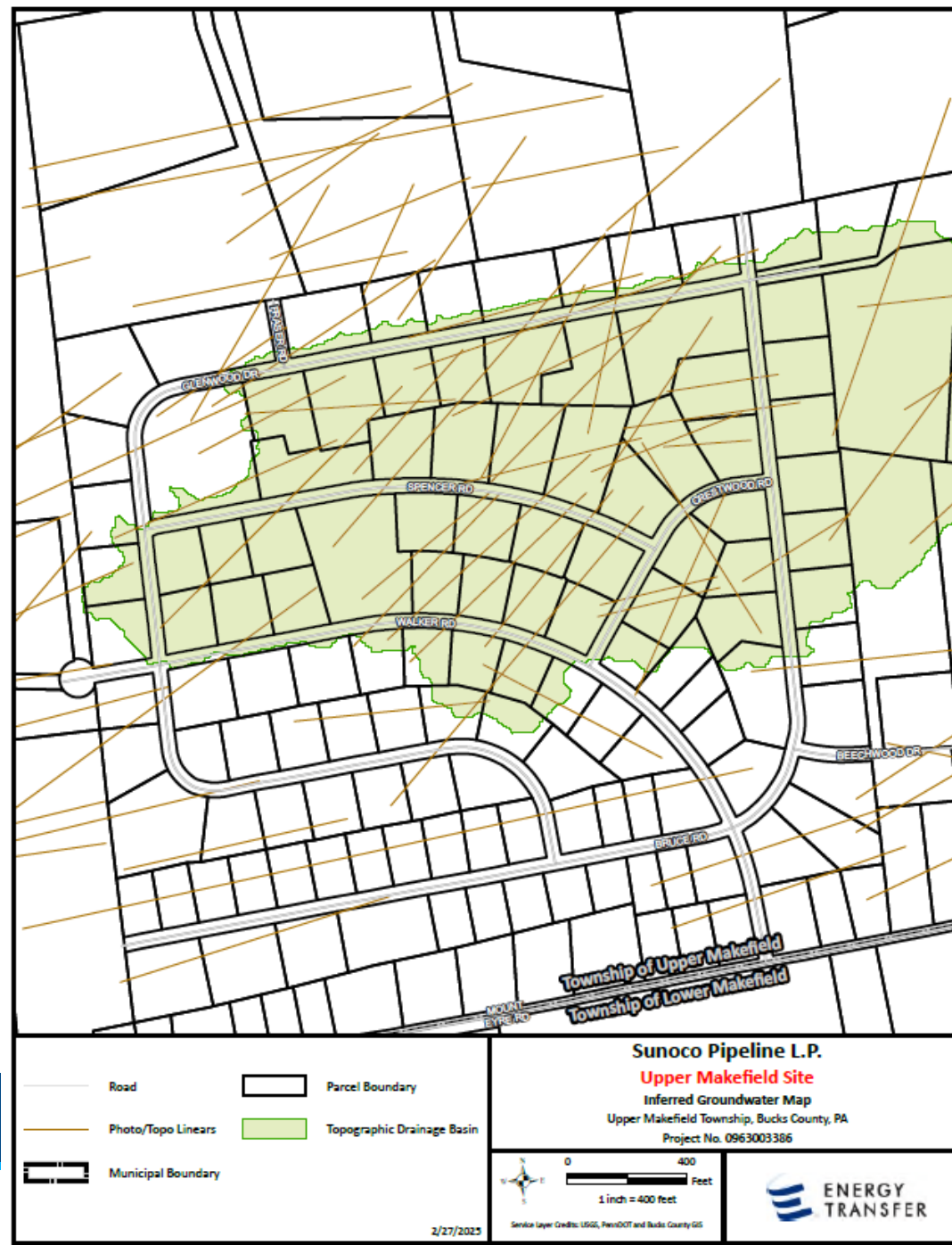

Energy Transfer has been addressing a pipeline release confirmed on Jan. 31 that impacted several private wells in the Mt. Eyre neighborhood of Upper Makefield Township. Energy Transfer operates a 14-inch diameter pipeline nearby that carries petroleum products such as gasoline, diesel and jet fuel.

## Actions Taken

Over the past several weeks, our employees and third-party contractors have worked around the clock to address all aspects of the incident. This includes water testing for residents, providing bottled water, and the installation of carbon filtration systems to impacted homes and those within a buffer zone.

The section of the pipeline where the leak was detected was removed and replaced, and the pipeline was placed back into service following the review and approval of the Pipeline and Hazardous Materials Safety Administration (PHMSA).

At the request of PHMSA, the pipeline is currently operating at a 20% pressure reduction. Our investigation into the cause of the leak is ongoing, and we are confident the pipeline is operating safely, under PHMSA's daily oversight.

We have completed a series of digs at certain other locations to visually inspect the line. We have completed six digs total in Upper Makefield Township and Newtown Township collectively, under PHMSA's oversight, at previously repaired locations and have found no evidence of other leaks.

consultants have performed more than 200 water tests for residents in the area and will continue these efforts. We continue to provide bottled water for concerned residents, which can be delivered or picked up at our Community Support Center.

## Water Filtration Systems

Energy Transfer's third-party water treatment consultants have begun to install Point of Entry Treatment (POET) systems, also referred to as carbon filtration systems, at certain homes in the investigation area. Energy Transfer is committed to covering the cost of the system appropriate for each home. Each system will be uniquely designed following individual site evaluations performed by certified and licensed third-party water treatment consultants.

## Remediation

Our crews are actively working to recover product from certain impacted wells and remediate the impacted area. The DEP continues to provide environmental oversight. Energy Transfer will continue to work with DEP for oversight of the remediation through the Act 2 process.

## Comprehensive Water Treatment System Installation

### Energy Transfer is Providing Advanced Water Filtration for Mt. Eyre

In addition to continuing to perform water sampling throughout the Mt. Eyre neighborhood, Energy Transfer is offering to install water treatment systems to either remove, or prevent the introduction of, certain contaminants from entering the water being used and consumed in homes. Residents have likely heard these treatment systems referred to as "carbon filtration systems" in recent weeks.

Energy Transfer is offering to install Point of Entry Treatment (POET) systems for homes in the Mt. Eyre neighborhood that are located within the topographic watershed where the release took place, as well as an additional buffer area, as determined with the guidance of third-party environmental consultants. This area is referred to as the "Investigation Area." A map showing the Investigation Area is available [using this link](#).

Energy Transfer is offering to install a POET system on all homes located in the Investigation Area at no cost to a resident. Energy Transfer is also committed to funding maintenance and servicing of the POET systems that are installed in the Investigation Area for a minimum of ten (10) years. Additional information regarding the proposed POET systems, follow-up sampling, and maintenance and servicing of the POET systems is provided on the next page.
