#### Dear David:

Sunoco Pipeline LP ("SPLP") is submitting the attached updated version of the Public Involvement Plan pursuant to the email that SPLP received from the Department on May 22, 2025, and the call between SPLP and the Department that was held on May 27, 2025. SPLP is also providing a response to each of the comments provided in the Department's email, as follows:

#### Department Comment:

1. SPLP indicated the public distribution list would be created. SPLP has already been performing activities subject to the PIP; therefore, the distribution list should be completed now. The PIP should identify public stakeholders (i.e., government entities and elected officials).

<u>SPLP Response:</u> SPLP has developed and begun using a distribution list for providing notices through electronic communications to known interested members of the public. SPLP will supplement that distribution list by allowing others to sign up for it in person at future public meetings and through SPLP's dedicated website. As discussed on our call, the PIP has been updated to identify the government entities and elected officials that will also receive the public notices.

# **Department Comment:**

2. DEP has a 60-day review period for Act 2 Statewide health standard reports. This is a statutory deadline. The revised PIP doesn't account for that.

<u>SPLP Response:</u> The PIP has been revised to reflect DEP's statutory deadline for reviews pursuant to Act 2 and to start the public comment period 15 days in advance of submittal to DEP per the discussion on our call.

## Department Comment:

3. Act 2 reports have review deadlines. DEP cannot be limited by the PIP to review other documents within a specified time period.

**<u>SPLP Response:</u>** The PIP has been revised pursuant to our call to remove the reference to "PADEP review period ends."

## **Department Comment:**

4. DEP's order requires SPLP to respond to comments by the township. We didn't receive responses from you to the PIP comments provided by the township or those by the resident task force.

**SPLP Response:** As discussed on our call, the Department's April 15, 2025 Letter of Deficiency for Public Involvement Plan specifically stated that it incorporated the comments that DEP received from the Township and from the resident task force. SPLP received a copy of those comments from the Department, reviewed them, and incorporated changes to the PIP pursuant to the Department's Letter.
